# Messy/water play

We appreciate you would like your child to look nice but when at pre-school we always have an area of messy play, whether that is with mud, water, sand, paints etc. so please dress them in their old clothes. Due to messy play, we would also remind you that all children will need a change of clothes in their school bag. (Named please)

### Water? Juice?

Last year we focused a term on healthy eating and oral hygiene. As part of this we looked closely and discussed with the children how much sugar is in juice. To reduce our sugar intake, we decided as a group that we would only have milk or water at snack time. We would now like to extend this further to include lunchtimes. Could I please therefore ask that you only send your child in with water with their lunch and save the juice for special occasions at home. They ALL drink water at preschool, even if they refuse at home!

# **Frube yoghurts**

Could we please ask you to refrain from putting these in your child's lunchbox, not only do children find them hard to open but we have had many yoghurt explosions over lunchtime, covering walls, themselves, and other children when they have tried to squeeze them open. A pot of yoghurt and a spoon are also great for children to practice their fine motor skills and co-ordination.

PLEASE NAME ALL PACKED LUNCH BOXES and SCHOOL BAGS. We are a nut free pre-school so please do not send your child in with any foods that contain nuts or MAY contain nuts. Please check ALL packaging.

### **Phonics Classes**

Phonics classes for our school leavers will be continuing this term. If you have any questions and want to know more please speak to Mrs Jordan and ask your child which sound they are learning.

## Administering medication at pre-school

We only administer medication to children if they are on a pre-school care plan and/or the medication has been prescribed by a doctor and has the child's full name and dosage on the bottle. A medication form will then be completed with the parent and signed by staff and parent at the end of the day.

Please DO NOT send your child in if they are unwell.



We would really like to hear about your children's achievements, special events and news, so please write anything they would like to share with us and their friends on a piece of paper, with their name and the date on the back and we will stick it on the news tree in the hall.

# The good old English weather



We endeavour to have outside play every day so please dress your child accordingly. This time of year, we can have sun, rain, wind, snow so please bring in a bag with sun hats, jumpers and a full change of clothing, in case your child gets wet or muddy through play.

Most importantly PLEASE NAME ALL CLOTHING.

### **General reminders**

- Children should come to pre-school in shoes suitable for both indoor <u>and</u> outdoor play i.e., <u>no Crocs/flip</u> flops.
- Long hair should be tied back.
- Label all drinks, bags, shoes, hats, and coats with your child's name.
- In accordance with Health Protection Agency guidance, children who are ill or who appear to be ill should not be at pre-school even if they are not infectious. Children with diarrhoea and/or vomiting should stay away from pre-school until they have been symptom free for 48 hours.

Please notify Tina Driver if your child can not attend pre-school.

# **FUNDING**

From the term following your child's 3rd birthday, your child is entitled to 15 hours free nursery education per week for 38 weeks of the year. These can be used as morning sessions (each session is 2.5 hours) or as full days (5 hours).

From April 2024 eligible working parents will be able to apply for 15 hours of funded education for their 2-year-old. For further details on the criteria and to obtain your code which we will need please visit the Government website.

We now offer more funded hours under the 30-hour scheme. To find out more and to check eligibility please visit kent.gov.uk/freechildcare or speak to a member of staff. We only have a limited number of spaces under this scheme so please speak to Tina or lo

We are also an approved provider of funding for 2-year-olds through the 'Free for 2' scheme. You can now apply online, please speak to a member of staff who will be able to give you full details.

You will be required to sign your funding declaration form termly. This is a binding document so please make sure you understand and check the content before you sign. If you have any questions, please speak to Tina or Jo.

# Are you entitled to Early Years Pupil Premium (EYPP)?

**Early Years Pupil Premium (EYPP)** 

Did you know your childcare provider may be entitled to £342 additional funding to further support the education of your child?

Your child's early years education provider could get up to £342 per year to help with your child's education. This will be paid direct to your provider.

### EYPP will help your child to:

- · benefit from extra resources and equipment suited to their needs
- enjoy a range of new play, learning and activity experiences
- be better prepared for starting school. Childcare settings will have to demonstrate to

Ofsted how funds have been used to improve your child's education.

#### Who can apply?

You can apply for early years pupil premium if your child is aged 3 or 4 and gets 15 hours free childcare.

If you are claiming one of the following benefits or credits, your provider may be able to claim additional funding for your child:

- Income Support Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- support under part VI of the Immigration and Asylum Act 1999
- the guaranteed element of State Pension Credit
- Child Tax Credit (provided you are not also entitled to Working Tax Credit and have an annual, household, gross income of no more than £16,190)
- Universal Credit (if you are entitled to Universal Credit and have an annual net earned income equivalent to and not exceeding £7,400, assessed on up to three of your most recent Universal Credit assessment periods.

EYPP may also be paid for children who meet the following criteria:

You may also get EYPP if your child is currently being looked after by a local authority in England or Wales or if your child has left care in England or Wales through:

- adoption
- · special guardianship order
- · a child arrangements order.
